IST through two-way video conferencing ("VC") via ZOOM Platform.**

I, Rupali Sanghi, Practising Company Secretary had been appointed as the Scrutinizer by the Board of Directors of the Bright Solar Limited ("the Company") pursuant to Section 108 of the Companies Act, 2013 ("the Act") read with Rules 20 of the Companies (Management & Administration) rules 2014 as amended by Companies (Management & Administration) Amendment Rules, 2015 to conduct Remote E-Voting as well as remote electronic voting during the 10th Annual General Meeting ("AGM") of the Company, held on Monday September 28, 2020 at 02:00 P.M. 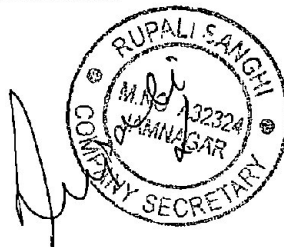

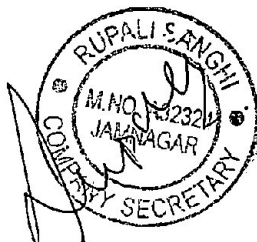

2. The Company has also placed the Notice of AGM on the web site of the Company at [www.brightsolar.in](http://www.brightsolar.in), on web site of E-voting Agency at [www.evoting.nsdl.com](http://www.evoting.nsdl.com) and on website of NSE at [www.nseindia.com](http://www.nseindia.com).
  3. The Company has given the newspaper advertisement for date and time of commencement and end of remote e-voting, remote electronic voting during AGM and AGM in;
    - A. Financial Express- Ahmedabad edition (English Language) on September 3, 2020 &
    - B. Financial Express- Ahmedabad Edition(Vernacular GujaratiLanguage) on September 3, 2020.
  4. The Company had availed facility offered by NSDL for conducting Remote E-Voting as well as remote electronic voting during the AGM by the Shareholders.
  5. The Shareholders holding Shares as on the "Cut off" date, i.e. Monday, September 21, 2020 were entitled to vote through Remote E-Voting as well as remote electronic voting during the AGM on the businesses mentioned in the Notice of AGM of the Company.
  6. In terms of the aforesaid Notice, Remote E-Voting was opened for three days which commenced on 9:00 A.M. on Friday, September 25, 2020 and ended on 5:00 P.M. on Sunday, September 27, 2020 and members of the Company, holding Equity Shares of the Company as on Monday, September 21, 2020, were required to cast their votes electronically, conveying their assent or Dissent in respect of the ordinary or special businesses, as the case may be, through remote e-voting platform provided by NSDL.
  7. The Remote E-Voting Platform was then after completed ("Blocked") in due time.
  8. Since this AGM was held pursuant to the MCA Circulars referred herein above through VC or OAVM, physical attendance of Members had been dispensed with. Accordingly, in terms of the above referred MCA and SEBI circulars, the facility for appointment of proxies by the Members were also dispensed with.
  9. Members attended the meeting through VC via ZOOM Platform had been counted for the purpose of reckoning the quorum under Section 103 of the Companies Act 2013.
